Biological monitoring can be a very useful complementary technique to air monitoring when air sampling techniques alone may not give a reliable indication of exposure. Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these measures are not sufficient to maintain concentrations of vapours below the Occupational Exposure Limits, suitable respiratory protection must be worn.
